## Invitation to Bid

The Municipal Government of Balayan (MGB), intends to apply the sum of following, to wit:

<b>Name of Contract</b>	:	<b>Construction of Access Road at Government Center (Phase IV)</b>
<b>Location</b>	:	<b>Barangay Caloocan, Balayan, Batangas</b>
<b>Approved Budget for The Contract (ABC)</b>	:	<b>Php 3,989,903.29</b>
<b>Project Duration</b>	:	<b>120 cd</b>
<b>Source of Fund</b>	:	<b>20% DF</b>

Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. Completion of the Works is required “see detailed project durations stated above each project”. Bidders should have completed a contract similar to the Project. The description of an **eligible bidder** is contained in the Bidding Documents, particularly, in **Section II. Instruction to Bidders**.
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders **may obtain further information** from **MGB Bids and Awards Committee (BAC) Secretariat** and inspect the **Bidding Documents** at the address given below from **9:00am to 4:00pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders starting **September 7, 2020 (9:00am)** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP 5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Bids and Awards Committee (BAC) will hold a **Pre-Bid Conference on September 15, 2020; 10:00am at the 2/F Municipal Hall, Balayan, Batangas** which shall be open to all interested parties.
7. **Bids must be duly received** by the BAC Secretariat at the address below **on or before September 28, 2020 at 10:00am**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

**Bid opening** shall be on **September 28, 2020 at 2:30pm** at BAC Secretariat Office, 2<sup>nd</sup> Floor, Municipal Hall, Balayan, Batangas. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
